

DF-17- Summary comparison of accounting assets vs. leverage ratio exposure measure

The leverage ratio acts as a credible supplementary measure to the risk based capital requirement. The Reserve Bank of India expects Banks to maintain Leverage Ratio of 4.5%. The Bank's Leverage ratio, calculated in accordance with the RBI guidelines as on 30.06.2019 is as follows:
